**INTERIM MANAGEMENT STATEMENT**

(Period from 01/07/2017 to 31/03/2018)

During the period, the profit amount 327 thousand EUR.

Financial incomes have decreased (901 thousand EUR compared to 953 thousand for the previous accounting year) due to lower loan amounts.

The Extraordinary General Meeting hold on the 10th June 2008 authorized the company to buy back its own shares pursuant article 2:98 of the Dutch Civil code. At 31 March 2018, 5,878 ordinary shares and 219 Founder's shares have been buy back by Mopoli.

The management do not foresee any specific or noted any new uncertainties that the company should have to face for the end of the current financial year.
